#### **Product Description**

3M<sup>™</sup> Dyneon<sup>™</sup> Fluoroelastomer FC 2144 can be compounded using standard water cooled internal mixers or two-roll mills with standard fillers and ingredients utilized in typical fluoroelastomer formulations. The "dry" ingredients should be blended before adding to the masticated gum. For best results, Dyneon FC 2144 should be banded on the mill several minutes prior to adding the blended dry ingredients. Once mixed, the compounded stocks have good scorch resistance and storage stability.

#### Product Form

FC 2144 is packaged in slab form and is available in a returnable bulk shipping container system for 1,320 lbs (600 kg) of material. The bulk container system is comprised of 48 individual green polyethylene bags containing 27.5 lbs (12.5 kg) of product. Smaller quantities are available in 55.1 lb (25.0 kg) boxes.

## Safety/Toxicology

Follow recommended handling precautions for use of 3M fluoroelastomers. General handling precautions include: (1) Store and use all 3M fluoroelastomers only in well ventilated areas.
